

14 INTERNATIONAL EXPERTS FROM 10 COUNTRIES

→ Austria, Brazil, France, Germany, Morocco, Poland, Portugal, Russia, South Africa and Switzerland





12 INTERNATIONAL EXPERTS FROM 8 COUNTRIES AND 2 LEGAL ENTITIES

→ Countries represented at the meeting were Brazil, Canada, Germany, Italy, Poland, Qatar, Russia, United Kingdom and United States. They were joined by representatives from legal entities Eurojust and Legisport





13 INTERNATIONAL EXPERTS FROM 8 COUNTRIES AND 6 LEGAL ENTITIES

→ Countries represented at the meeting were Austria, Brazil, France, Germany, Poland, Qatar, Spain, and Ukraine.

They were joined by representatives from legal entities Legisport, International Association of Sports Law, Pan European Think Tank of Football Safety and Security, Council of Europe, Emergency Planning College and the Sports Ground Safety Authority





MAJOR SPORTING EVENT SECURITY LEGISLATION GANTT CHART

- → **Aim:** Set out the critical path of activities and key focus areas associated with developing legislation to police and secure major sporting events
- → **Process:** The Gantt Chart is drawing on research, presentations and conclusions drawn from the Sports Legislation Experts Group meetings, and input and recommendations from global experts

→ Outcome:

The document is providing:

- ✓ a list of issues to cover (e.g. crowd control, international cooperation, ticketing fraud, etc.)
- ✓ a short description / explanation for each topic,
- ✓ contributions from experts,
- ✓ and the amount of time that should be allowed to complete each activity.
- ightharpoonup This document could bring valuable and useful recommendations on legislation requirements as they relate to the delivery of a major sporting event, and contribute, in a complementary way, to the planning of legislative amendments
